This DEED OF PUBLIC RELIGIOUS TRUST ie. "MURLI MANOHAR THAKUR JI CHARO DHAM TRUST™ is made on 09th July in the Year 2024 by Shri Arvind Kumar Jha, s/o Shri Radheshyam Jha, resident of H-11/3, Bhavani Gali, Aali Vihar, Sarita Vihar, South Delhi, Delhi, 110076, India & who is the Founder, Author, SETTLOR of "MURLI MANOHAR THAKUR JI CHARO DHAM TRUST".

AND WHEREAS to attain the aims, goals & objectives as set out hereinafter, the Founder, Settlor & Author' Arvind Kumar Jha has put aside a sum of Rs. 1,11,000/- (Rupees One lakh Eleven Thousand only) as the initial Corpus Fund for the purpose of settling/making this Trust.

AND WHEREAS upon the request of the Founder, Settlor & the Author, the following persons namely:

(1) Shri. Radhey Shyam Jha, S/O Late Shiv Gulam Jha permanent r/o At/Po: H-11/3, Bhavani Gali, Aali Vihar, Sarita Vihar, South Delhi, Delhi, 110076, have agreed to be the Trustee of the said Trust to which the aforesaid persons have volunteered & given their valid open consent.

(2) Smt. Arti Devi Jha, D/O Yadu Nandan Mishra permanent r/o H-11/3, Bhavani Gali, Aali Vihar, Sarita Vihar S.O, South Delhi, Delhi-110076 have agreed to be the Trustee of the said Trust to which the aforesaid persons have volunteered & given their valid open consent.

NOW THIS DEED OF DECLARATION OF "MURLI MANOHAR THAKUR JI CHARO DHAM TRUST" WITNESSETH AS UNDER:

1. CREATION OF THE TRUST:

Arvind Kumar Jha hereinafter to be referred as founder of the Trust hereby creates the said Trust ie. "MURLI MANOHAR THAKUR JI CHARO DHAM TRUST" & declares as under:

That the sum of Rs.1,11,000/- (Rupees One Lakh Eleven Thousand only) settled as the settling amount of the TRUST on aforesaid date, shall be treated as forming part of the corpus of the "TRUST" as declared in terms of these presents and shall always be treated as such and shall always

deemed to have been settled irrevocably for the attainment of 'aims' and 'objectives', as stated hereinafter.

2. OFFICES OF THE TRUST:

- i) The Registered office of the aforesaid Trust will be situated at **Galimpur, Bhurkurwa, Rajepur, East Champaran, Bihar, 845401** or at such other place as the Board of Trustees may decide in due course of time in case of any eventuality.
- ii) The head office and/or other branch office(s) of the Trust shall be opened at any such place(s) in India and abroad as the Board of Trustees may decide from time to time.

3. AREA OF OPERATIONS:

- i) The activities of the aforesaid Trust are & shall not be limited only to Geographic limits of the Republic of India but shall be operative, exercisable & will be spread over to each & every part of the Globe for the benefit of all people, irrespective of race, creed, caste, religion, sect and nationality as it is quite imperative for the attainment of true goals & objectives of the said Trust.
- ii) And for achieving the same the Managing Trustee with the mandate of Board of Trustees shall give charge or engage, appoint devotees, preachers, teachers, trainers, followers & volunteers in India & abroad for propagation of the aims & objectives of the Trust & also to participate in national as well as international events, forums of similar nature.

4. AIM, GOALS & OBJECTIVES OF THE TRUST:

- I. **Main Aim of the Trust** is to open, set up, establish, maintain & run Temples, Museums, Ashrams and other premises meant for worship of God, spiritual enhancement of mind, body, heart & soul of the peoples of the society & humankind.
- II. To teach and educate the true knowledge of Divya Bhakti Yog & spirituality as given by the original scriptures like: the Vedas, Upanishads, Bhagavad Geeta, and the Shrimad Bhagavatam etc., which are of universal nature, irrespective of caste, creed, religion, sect and nationality, by organizing retreats, camps, shivirs, programs, yatras, events, etc. & also to spread awareness of the same by distributing literature in conventional form as well as through approved media, also electronic media.
- III. To set up, establish, maintain & run institutions for doing research in the realms aforesaid & also for making, publishing, creating the literature, softwares electronic media in context to the aforesaid activities.
- IV. To undertake humanitarian work for the suffering masses by alleviation of mental diseases, which have gained a stronghold in the modern world.
- V. To take up medical welfare work, education and training of yoga, social welfare, relief work, or any such project or activities that are found essential from time to time for well-being of humanity.

- To open, set up, establish, maintain & run hospitals, nursing homes, outdoor dispensaries, mobile medical hospitals & also to assist existing free or low-cost hospitals in order to help the poor, down trodden & weaker sections of the society.
- VII. To set up, organize & conduct nutritional, health, de-addiction & rehabilitation medical camps & also to organize & set up blood donation camps, blood banks, eye banks & other duly approved health services.
- VIII. To open, set up, establish, maintain & run charitable night shelters, Dharmshalas, Ashrams & Goshalas & also to provide food, clothes to the needy & weaker sections of the society.
- IX. To open, set up, establish, maintain & run old age homes, orphanages, homes for mentally retarded, blind, handicapped / disabled persons & also to assist already existing.
- X. To open, set up, establish maintain & run libraries, museums meant for spiritual enhancement of mind, body, heart & soul of the peoples of the society & humankind.
- XI. To undertake research work for the physical, mental, intellectual and spiritual growth, health of humankind.
- XII. To set up, establish, maintain & run educational institutions, such as schools, colleges and universities for imparting formal spiritual & conventional as well as modern education. And also help existing educational institutions along the above lines.
- XIII. To set up, establish, maintain & run nurseries, kindergartens for the children to imbibe & inculcate moral sanskaras & spirituality in them for making them healthy mentally as well as physically.
- XIV. To promote, propagate, set up, establish, maintain & run the institutions relating to the Sciences of Ayurved, Naturopathy and other Alternative healing Systems for Treatment of Diseases.
- XV. To promote, propagate, and engage in organic farming for producing healthier foods for the health of humankind.
- XVI. To popularize the use of natural herbs, to research, manufacture and market Ayurvedic products for low-cost treatment of diseases by setting up, establishing, maintaining & running institutions allied to Ayurved.
- XVII. To teach and promote the knowledge of Dietary Sciences and Sattvic Vegetarian food for health improvement and maintenance.
- XVIII. To give charge or engage, appoint devotees, preachers, teachers, trainers, followers & volunteers in India & abroad for propagation of the aims & objectives of the Trust & also to participate in national as well as international events, forums of similar nature.
- CIX. All such incidental activities, work, acts which are necessary to achieve the main aim as stipulated in the above objective of the Trust.

To establish a Research Centre for undertaking research work in spiritual, secular and yogic branches of knowledge.

- XXI. Plan, manage and organize yog education and training, through shivirs, discourses, sammelans, sankirtan programs and other occasional programs and events related to local festivals, etc., linked with the ancient culture and social heritage of India.
- XXII. Organize and manage yog shivirs and devotional classes for the desirous persons and devotees and also to undertake other activities or celebrations related to the physical, mental, intellectual and spiritual happiness of the devotees.
- XXIII. To provide all reasonable facilities to the yog teachers, and preachers, and volunteers considering their services rendered to the Trust.
- XXIV. To adopt modern means for propagating the workings of the Trust. To publish, produce, and sell books, literature, magazines, audio and video cassettes & CDs, etc., for the benefit of the Trust. The outcome of the works mentioned herein shall be used only for the working and the development of the Trust.
- XXV. To accept gifts, donations, contributions and offerings in any form of moveable or immoveable property.
- XXVI. To acquire land for the use and development of the Trust. Acquire, construct, purchase, or take on hire any moveable or immoveable property for the use, benefit, or goodwill of the Trust and to manage and protect the same.
- XXVII. To acquire, take over, merge or amalgamate or associate or affiliate with or enter into any partnership or joint venture arrangement with any other public charitable Trust, educational institution, research institution, students, academicians, or any bonafide individual, in any part of the world, for fulfilment of any of the objects in this Deed, or terminate their affiliations at its discretion.

5. THE MANAGING TRUSTEE, TRUSTEES AND BOARD OF TRUSTEES.

- a. That for effectuating the aforesaid declaration Arvind Kumar Jha, the 'Founder' of the Trust shall be the 'Managing Trustee' of the aforesaid 'Trust' throughout his life & the persons following namely:

- (1) **Shri. Radhey Shyam Jha**, S/O Late Shiv Gulam Jha permanent r/o At/Po: H-11/3, Bhavani Gali, Aali Vihar, Sarita Vihar, South Delhi, Delhi, 110076
- (2) **Smt. Arti Devi**, D/O Yadu Nandan Mishra permanent r/o H-11/3, Bhavani Gali, Aali Vihar, Sarita Vihar S.O, South Delhi, Delhi-110076

shall be the other Trustees, who have given their consent to be the Trustees of the TRUST and have accordingly agreed to become parties to this declaration, by putting their signatures on this Trust Deed, so as to form a Board of Trustees.

b. Management of the Trust:

the Board of Trustees shall consist of the Managing Trustee as well as the aforesaid other one Trustee. The Managing Trustee who is a founder Trustee as well as the Settlor shall as with the mandate of the Board of Trustees shall be entitled to increase the number of Trustees as and when situation demands & is necessitated in the interest of the achievements of the goals of the Trust. However, the total number of members of the Board of Trustees shall never be less than Three & shall never exceed Ten. And no foreign citizen shall ever be the Trustee of the said Trust.

That all the major decisions shall be taken by the Board of Trustees. The Trustees including the Managing Trustee will have equal votes. In case the total number of votes of the Trustees happens to be equal in number, the Managing Trustee shall have the power to cast an extra vote to decide on the matter.

That the Managing Trustee shall be the President of the aforesaid Trust, throughout his life.

That the Managing Trustee, in consultation & with the mandate of Board of Trustees, shall appoint the office bearers, who could even be from & among the Trustees for the efficient & smooth functioning of the Trust. The powers, duties of the Office Bearers shall be assigned by the Managing Trustee.

6. DUTIES OF THE TRUSTEES:

That for the implementation and the attainment of the aims and objectives of the Trust & for the proper conduct of the affairs of the Trust, the Board of Trustees are empowered to do the following acts:

- a. To employ, engage or otherwise retain the services of such persons as may be necessary or desirable for carrying out the work of yog education, Charity or in furtherance of the objects of the Charity on such terms as may be thought fit and to make all reasonable provisions for the payment of pensions and superannuation to employees.
- b. To create such Advisory Boards and Committees as the Board of Trustees may deem fit for achievement of the aims and objectives of the Trust.
- c. To establish or support any other yog institutions, charitable Trusts, associations or institutions formed for any of the charitable purposes included in the objects.
- d. To take such advice professional or otherwise as the Board of Trustees consider appropriate for the management or administration of the yog activities, Charity and to make payment out of the Trust Fund in respect of the costs fees and expenses for and in relation to any such advice.
- e. To do any other lawful thing that is necessary or desirable for the achievement of the aims & objects of the Trust
- f. It shall be lawful and competent for the Board of Trustees to receive or make, transfer, gifts, donation or provide any facility to its sister concern or other charitable organizations.
- g. To deal with any legal cases in the interest of the Trust.

PROPERTIES OF THE TRUST:

entire property of the aforesaid Trust shall vest in the aforesaid Board of Trustees of the Trust.
The properties of the Trust shall be-

- i. the said sum of Rs 1,11,000/- above referred to the receipt of which is hereby acknowledged by the Trustees;
- ii. any properties movable or immovable, that may be acquired by the Trust either by purchase or otherwise;
- iii. all additions and acceptations to the Trust fund;
- iv. all voluntary donations both towards corpus or otherwise gifts, legacies or grants in cash or in kind accepted by the Trustees;
 - v. all grants and contributions made to the Trust by the Government, Government bodies, Trust or Institutions, Trade Union or Societies etc; and
 - vi. all sums and assets which by and means become the property of the Trust.

8. MEETINGS OF THE BOARD OF TRUSTEES:

- a) The President shall preside over all the meetings of the Board of Trustees and in his absence, the Trustees present in the meeting may elect any one of them to preside over the meeting but no major decision shall be taken without the due valid consent of the Managing Trustee.
- b) The meetings of the Board of Trustees may be convened by the President or under his direction by any other Trustees.
- c) The quorum of the meeting of the Board of Trustees shall be the presence of at least two Trustees inclusive of the Managing Trustee.
- d) In the event of equality of votes, President cum Managing Trustee shall exercise casting vote (additional vote).
- e) The notice of the meeting of the Board of Trustees shall be intimated by circulation fifteen days in advance through any valid mode except oral.

9. RESOLUTIONS:

The Board of Trustees may exercise all the powers vested in them through this Trust deed, by a resolution passed by the Board of Trustees by a simple majority.

10. ACCOUNTS AND AUDIT:

- a. The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.
- b. The year of account shall be the financial year commencing from 1st APRIL and ending 31st MARCH.
- c. The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.
- d. The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the board of Trustees and the audited statement of accounts together with Auditors' report shall be laid before the Board of Trustees for approval.

11. BANK ACCOUNTS:

On behalf of & with the mandate of the Board of Trustees, the Managing Trustee shall have Authority to open Bank Account/Accounts in any Bank, as may be required from time to time shall be operated by the Managing Trustee or by any Trustee/s and/or any person/s as may be specially Authorized by the Managing Trustee.

POWER TO MAKE, ALTER RULES AND REGULATIONS:

The Board of Trustees shall have full power and Authority to make, alter and rescind rules and regulations for the management and administration of the Trust.

APPLICATION OF INCOME AND TRUST FUNDS:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the Trust provided that such investments shall be in accordance with the provision of Section 13(1) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable Trusts.

REMUNERATIONS OF TRUSTEES:

The Trustees are not entitled for any remuneration. But they shall however be entitled to receive out of pocket expenses incurred by them in the course of discharging the functions of the Trust. Further the Income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way profits, interest, dividend or otherwise.

INDEMNITY:

Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

In the execution of the Trusts hereof no Trustee shall personally be liable for any loss to the property of the Trust arising by reason of any improper investment made in good faith (so long as he shall have sought professional advice before making such investment) or for the negligence or fraud of any agent employed by him or by any other Trustee hereof in good faith (provided reasonable supervision shall have been exercised).

POWER OF DELEGATION:

In addition to their statutory powers and the powers conferred by this Deed, the Managing Trustee &/or the Board of Trustees may delegate any of his/their powers or functions to a committee appointed by the Managing Trustee with the mandate of Board of Trustees for a specific task, specific purpose & for a specific period cum tenure. The said committee so appointed must act in accordance with any directions given by the Board of Trustees. It must



report its decisions and activities fully and promptly to the Board of Trustees. It must not incur expenditure on behalf of the Charity except in accordance with a budget previously agreed by the Board of Trustees. The Board of Trustees shall consider & monitor from time to time whether the powers or functions which they have delegated should continue to be delegated. That in the eventuality of a situation when any single Trustee has to delegate his power so granted to him vide this Trust deed, he/she shall be capable to delegate his/her power vide a letter of Authority with due approval from the Board of Trustees/Managing Trustee.

17. POWER OF INTERPRETATION.

In case of any matter related to interpretation of the Trust Deed or the rules framed there under or any other related matter, the same would be referred to the Managing Trustee, whose decision on the subject would be final.

18. POWER OF INCIDENTAL MODIFICATION.

That the Managing Trustee can make additions or subtractions in the present Trust Deed within six months from its execution for the limited purpose of bringing it in conformity with any statute to achieve the aims and objectives of the Trust in accordance with the laws of the land.

PROVIDED that such additions or variations would not change the essential character of the Trust Deed.

19. EXECUTION OF DOCUMENTS:

All Deeds, Documents etc. shall be executed primarily by the Managing Trustee only on behalf of the Trust & in case of any exigency by any other Trustee or any person vide a letter of Authority indicating a specific task/purpose for a specific time frame & with sanction, approval and mandate of Board of Trustees.

20. RESIDUARY:

For matters not provided for in these presents, the provisions of laws and statutes specially enshrined in any Act(s) passed by the Parliament of India & in consonance with the Constitution of India applicable to such sort of a Trust will apply accordingly & in case of any disputes, litigation in foreign lands the same shall be covered in consonance with the treaties/mutual laws of the Republic of India with the country where such dispute has occurred along with the applicability of the international laws.
